Regulations on the Implementation of the Procurement Procedures for NonCompulsory Persons in the Public Procurement Act (hereinafter: „the Regulations“) (NOJN), in the procurement procedure of machines within the project "Investment in construction and equipping of new production hall for the production of cutting tools" - contract number: KK.03.2.1.15.0064., Registration Number 2/2020, estimated procurement value HRK 3,003,970.92, provides the following

DECISION ON CANCELLATION

1. The procurement procedure for groups of procurement subjects is canceled:

GROUP	GROUP NAME
2	Wide Band saw blades Flash Butt Welding Machine
6	Tensioning, straightening and levelling machine

2. The new procedure for groups 2 and 6 of the procurement subject will be initiated within 30 days from the day of publication of the notice on cancellation of the procurement procedure on the website of the Contracting Authority.

Explanation

Procurement notice with the intention of concluding a contract for the procurement of goods was published on the website www.strukturnifondovi.hr on 22nd of August 2020.

The subject of procurement was divided into seven groups:

1	Band saw blades CNC profile/side sharpening machines
2	Wide Band saw blades Flash Butt Welding Machine
3	Band saw blades CNC deep grinding machine
4	Automatic welding of special alloys on band saw and circular saw blades teeth
5	Screw Compressor
6	Tensioning, straightening and levelling machine
7	CNC Band Saw Tensioning, straightening and levelling machine

The opening of bids was held on September 15th, 2020, starting at 11:00 AM, and it was determined that bids were received for groups 1 to 5 and group 7 of the procurement item, while no bids were received for group 6.

For group 2 of the procurement item, it was determined that one bid of the bidder IDEAL-Werk C. + E was received. Jungeblodt GmbH + Co. KG, Bunsenstrasse 1, D-59557 Lippstadt, SR Germany, Padebron HRA 3423, markings: K.K.03.2.1.15.0064 dated 9th of September 2020. Upon review of

the subject bid, it was determined that it is contrary to the provisions of the Bidding Documents, ie it does not meet the conditions related to the properties of the subject of procurement. Namely, in the part of the bid validity period - the bidder determines the bid validity period of 30 days from the deadline for submission of bids, while point 4.6. documentation stipulates that the bid validity period must be at least 90 days from the deadline for submission of bids, the bid does not specify the content of the bid, which is contrary to the provisions of point 4.1. documentation, and in the part of the offered subject of procurement under ordinal number 12 of the form "Technical characteristics of machines" for group 2, it was requested that the offered subject of procurement has "Water cooler for cooling electrodes during welding", the bidder states in the commentary order as a separate unit, which means that the offered machine does not have the required technical feature or that the required technical feature should be additionally ordered and which is contrary to the required in the tender documentation or offered does not meet the requirements related to the properties of the subject. Following the above offer of the bidder IDEAL-Werk C. + E. Jungeblodt GmbH + Co. KG had to be rejected on the basis of point 14 of Annex D- Rules on the implementation of procurement procedures for non-payers of the Public Procurement Act (NOJN)

Pursuant to the above, in accordance with item 11, indent 3 of the Rules, the contracting authority cancels the procurement procedure for the procurement of machinery for group 2, while pursuant to item 11, indent 1 of the Rules, the procurement procedure for the procurement of machinery for group 6 of the procurement is canceled.

Following the above, it was decided as in the dictum.
